Dear Mr. Langer:

I have received a copy of your memorandum dated December 8, 1997, requesting intervenor status in the above referenced docket. Your memorandum does not appear to conform to Commission rules concerning the filing requirements for intervention.

Rule 25-22.039, Florida Administrative Code, provides that persons seeking to intervene in a pending Commission proceeding should file a petition for leave to intervene. The petition must conform with Rule 25-22.036(7)(a), Florida Administrative Code, and include allegations sufficient to show that the petitioner's substantial interests are subject to determination or will be affected through the proceeding, i.e., that the petitioner has standing to intervene. Pursuant to Rule 25-22.0375, Florida Administrative Code, the original petition and seven copies must be submitted to the Division of Records and Reporting and copies shall be served on all parties of record.

Please note that this docket is not currently set for hearing; it is being handled through the Commission's "proposed agency action" process. Under this process, any person may participate without formal intervention. By informing the Division of Records and Reporting that you are interested in this docket, you may receive notice of and participate at the Commission's agenda conference when discussion on this docket is heard and a vote is taken. (You will not, however, have party status unless leave to intervene is granted.) Any person whose substantial interests are affected by the Commission's decision may protest the decision by petitioning for a hearing on any disputed issues within 21 days after issuance of the Commission's proposed agency action order.


