

ORDER GRANTING MOTION TO INTERVENE


THIS MATTER having come before the Administrative Law Judge for review on the Public Service Commission's Motion to Intervene, pursuant to Rule 60Q-2.010, Florida Administrative Code; and having reviewed the Motion and Petitioner's Response in Opposition to Petition to Intervene, and being fully advised in the premises, it is

FOUND AND DETERMINED that under the provisions of the Administrative Procedures Act, standing to intervene in an administrative hearing provided for in Section 120.57(1), Florida Statutes, is limited to those persons who can demonstrate that they will be substantially affected by the agency determination in this matter. It appears that the Petition for Leave to Intervene filed by the Public Service Commission conforms to the requirements of Rule 60Q-2,101, Florida Administrative Code, as well as, Rule 25-22.026(3), Florida Administrative Code. It is, therefore,



ORDERED that the Public Service Commission's Motion to Intervene is granted and shall be considered a party Respondent for all purposes related to the Petition filed in this matter. See: Rules 60Q-2.010 and 60Q-2.004(5) and 25-22.026(4), Florida Administrative Code.
