Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and Unique Communications, Inc. are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to Unique Communications, Inc. The original agreement was filed on March 11, 1997 in Docket 970301-TP.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the amendment between BellSouth and Unique Communications, Inc. within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties aver that neither of these reasons exist as to the agreement they have negotiated and therefore, are very hopeful that the Commission shall approve their amendment.

**AMENDMENT  
TO  
RESALE AGREEMENT BETWEEN  
UNIQUE COMMUNICATIONS, INC.  
AND  
BELLSOUTH TELECOMMUNICATIONS, INC.  
DATED APRIL 29, 1997**

Pursuant to this Amendment to the Resale Agreement (the "Amendment"), Unique Communications, Inc. ("Unique") and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to collectively as the "Parties" hereby agree to amend the Resale Agreement between the Parties dated April 29, 1997 ("Resale Agreement").

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Unique and BellSouth hereby covenant and agree as follows:

1. Strike "WHEREAS, Unique is or seeks to become an alternative local exchange telecommunications company authorized to provide telecommunications services in the state of Florida; and"

2. Insert "WHEREAS, Unique is or seeks to become an alternative local exchange telecommunications company authorized to provide telecommunications services in the state(s) of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee; and

3. Paragraph A. of Section I of the Resale Agreement is hereby deleted in its entirety and shall be replaced with the following:

A. The term of this Agreement shall be two years beginning April 29, 1997 and shall apply to all of BellSouth's serving territory as of January 1, 1997 in the state(s) of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee.

4. All of the other provisions of the Resale Agreement shall remain unchanged and in full force and effect.

5. Either or both of the Parties is authorized to submit this Amendment to the appropriate state Public Service Commissions or other Regulatory Agencies for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
