Pursuant to Section 367.045(4), Florida Statutes, and Florida Administrative Code Rule 25-30.031, the City of Wildwood hereby files its amended response to the Notice of Application to Amend Water and Wastewater Certificates filed by Little Sumter Utility Company and states:

- 1. Upon review of the Notice of Application to Amend Water and Wastewater Certificates, it appears that the territory described therein located in Sumter County, Florida, falls within the Five Mile Utility Zone created by the City of Wildwood by Ordinance No.: 19-369 pursuant to Chapter 180, Florida Statutes.
- 2. The City attorney for the city of Wildwood had understood that the City Commission of the City of Wildwood had voted to object in general to applications for any area within the five-mile zone created pursuant to Chapter 180, Florida Statutes, but that they did not object to the area being requested in this specific application and filed the original objection conveying that information to the Commission. However, she has learned that the actual motion passed by the Commission did include an objection to this particular property also.

Expansion of the Water and Wastewater Certificates will infringe upon the City's rights and obligations created by the establishment of the Five Mile Utility Zone and the City's Local Comprehensive Plan.

- 4. The City depends upon revenue from its water and sewer department and wishes to provide services in the area of its five-mile zone sought to be included in the Little Sumter Utility Company service area.
- 5. The City has plant capacity to provide water and sewer services to the area that Little Sumter Utility Company seeks to include in its service area although it does not currently have lines to that area.
