

BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Notice of Intent to Request Specified Confidential Classification for the Business Plus and Area Plus Monthly Report.

1. In a Memorandum dated February 20, 1998, the Florida Public Service Commission ("Commission"), requested BellSouth to begin reporting Business Plus and Area Plus information, which includes minutes billed and total usage by customers. This information is to be provided on a monthly basis for a period of six months. The above information is competitively sensitive.

2. The information contained in this monthly report is proprietary and entails information that is clearly confidential and proprietary under Florida Statutes, Section 364.183.

3. Because this report contains proprietary information, BellSouth is filing this Notice of Intent to Request Specified Confidential Classification, pursuant to Rule 25-22.006(3), Florida Administrative Code, in order to allow the Commission Staff to take possession of the report without delay.
