Our review of the application indicates that the minimum filing requirements for the above referenced application are incomplete. The specific deficiencies concern using a different name for the utility in this case: Town & Country Utility Company, and that listed with the Secretary of State, Florida Division of Corporations: Town and Country Utilities Company. Since the names are different, this incompatibility must be corrected. For example, the lease agreement is listed in the name of Town & Country Utility Company, not Town and Country Utilities Company. Until these apparent errors are corrected, the application for this case will be deemed deficient.
