

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that BellSouth Public Communications, Inc.'s petition for exemption from the requirement of Rule 25-24.515(8), Florida Administrative Code, filed August 6, 1998, in Docket No. 981002-TC was approved by the Commission at its October 6, 1998, Agenda Conference. Order No. PSC-98-1457-FOF-TC, issued October 26, 1998, memorialized the decision. The rule addresses the requirement that each pay telephone station shall allow incoming calls. The petition was approved on the basis that the purpose of the underlying statute would be achieved by other means and application of the rule would create substantial hardship. Notice of the petition was published in the FAW on August 28, 1998.
