Dear Mr. Wenz:

Thank you for your February 16, 1999, response to my deficiency letter of December 24, 1998. We have found that your responses for two issues were incorrect. I have enclosed instructions for preparing your responses to the following deficiencies.

Pursuant to Rule 25-30.030(5)(a), F.A.C., the utility is to provide a description of the remaining territory using township, range, and section references. The information provided did not include proper territory descriptions including distances from point to point.

Pursuant to Rule 25-30.030(5)(b), F.A.C., the utility is to provide one copy of the official county tax assessment map, or other map, showing township, range, and section with a scale such as 1"=200' or 1"=400', with the remaining territory plotted thereon by use of metes and bounds or quarter sections, and with a defined reference point of beginning.

In reviewing your February 16, 1999, letter it is apparent that 40 service lines and meters in the Oakland Shores system are being sold to the City of Maitland. Please explain why these are being transferred.

Please provide one copy of the map, and the original and five copies of the remaining requested information no later than May 4, 1999, with Ms. Blanca Bayo, Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399-0850. If you
