Re: Water Certificate 139-W, Application for Name Change

Dear Director:

Enclosed you will find a letter we recently received from John D. Williams, Chief, Bureau of Policy Development and Industry Structure. Mr. Williams' letter indicated that we need to file an application to change the name of our utility. Apparently, according to PSC records, the name of our utility is Dixie Grove Estates, Inc., and something was brought to the attention of his department that the name we are using is Dixie Groves Estates, Inc. The only difference being a letter (s) on the word Groves.

This corporation was formed 10-07-1957. The name on the Corporate charter with the State of Florida Department of State is Dixie Groves Estates, Inc. This is also the name that is on our water tariff, tax returns, stock certificates, and D.E.P. and SWFWMD permits. This is the same name which has always been on these items. We therefore are not filing the name change application because we feel the error was made by PSC Staff some time ago. As I said already, our current approved tariff says Dixie Groves Estates, Inc. It is also an example of creating a mountain out of a mole hill. It is a difference of a letter (s), not anything that completely distorts the name. We therefore suggest that you simply correct your records to what it should have been since 1957.

Dear Mr. Potter:

It has come to our attention that a question exists as to the official name of your utility. In 1973, your original water certificate was issued in the name of Dixie Grove Estates, Inc., as indicated on the original application form. This year we mailed a form to verify various information about your utility and received a correction indicating that the name is Dixie Groves Estates, Inc. Consequently, a formal name change request must be submitted if you would like to officially change the utility's name with the Public Service Commission.

Enclosed is an information package for a name change. Included in this package are:

1. Application for a name change pursuant to Section 367.121, Florida Statutes.
2. Chapter 25-30, Florida Administrative Code, details the rules promulgated to carry out the jurisdiction of the Commission over private water and wastewater utilities. A copy of Rule 25-30.039 regarding an application for a name change is enclosed for your information.
3. Sample water tariff which will contain all of the utility's rules, regulations, rates and charges. Since the existing tariff must be replaced in its entirety to reflect the utility's name change, the revised tariff should be numbered as new original sheets under the utility's proposed name change. A computer disk containing the tariffs in WordPerfect format may be obtained by contacting the staff.


