As grounds for the Motion, BellSouth advises the Florida Public Service Commission that:

1. There may be an opportunity for this matter to be completely resolved; thus BellSouth requests additional time to explore that possibility before the Commission expends time and resources adjudicating this Complaint.

2. Granting BellSouth an extension of time through and including December 21, 1999 to file a response to TCCF's Complaint will prejudice neither party.
