AT&T's Fourth Claim for Confidential Treatment

Dear Ms. Bayó:

AT&T Communications of the Southern States, for itself and its affiliate AT&T Wireless Services (collectively hereinafter "AT&T"), pursuant to Section 364.183(1), Florida Statutes, hereby claims that certain information provided in response to Water D'Haeseleer's April 11, 2000, data request for telephone number utilization data contains confidential and proprietary business information that should be held exempt from public disclosure. Pursuant to Rule 25-22.0006(5), Florida Administrative Code, in the attached envelope identified as Exhibit "A" is one paper copy of AT&T's response (consisting of Attachment "I") with the confidential information highlighted and one electronic copy of the document as an Excel 2000 spreadsheet file on an IBM compatible 3.5" disk. Attached as Exhibit "B" are two paper copies of AT&T's response (consisting of Attachment "I") with the confidential information redacted. Parties of record are not being provided a copy of the redacted filing as it is too voluminous; any party wanting to review the redacted copy may contact me to receive a copy of the redacted document.

AT&T has attempted to provide responses consistent with the definitions provided in the Staff's instructions. However, in order to provide a meaningful response, some of the responses may have been prepared consistent with industry practice, guidelines, or the FCC's recent Order No. 00-104 decision. At this time, AT&T is unable to provide information responsive to Attachment "II," the projected 1000s block demand by NPA-NXX/exchange for the months of May 2000 to October 2001, as AT&T does not have such information in the form or manner requested.

This claim of confidentiality was filed by or on behalf of a "telco" for Confidential DN 05387-00. The document is in locked storage pending advice on handling. To access the material, your name must be on the CASR. If undocketed, your division director must obtain written EXD/Tech permission before you can access it.



By providing this information, AWS should not be construed as a "telecommunications company" for purposes of chapter 364 nor should AWS be considered to have waived any position with respect to the Commission's jurisdiction, pursuant to the FCC's Order No. FCC 99-249, issued September 15, 1999, to obtain number utilization data from CMRS providers.
