On April 18, 2000, Adelphia Business Solutions Investments, LLC and Adelphia Business Solutions of Florida, LLC ("Adelphia of Florida"), filed an Application for Authority to Merge and to Transfer Licenses as Part of a *Pro Forma* Corporate Restructuring. After the Application was filed, however, the corporate parent of these entities, Adelphia Business Solutions, Inc., decided that Adelphia Business Solutions Investments, LLC would instead be named **Adelphia Business Solutions Investment, LLC**. This letter, therefore, requests that the Commission reflect the change from Investments to **Investment** in the caption of the Docket as well as reflect in the Commission's Order that Adelphia of Florida's certificates and operations will be assumed by **Adelphia Business Solutions Investment, LLC**.
