1. Charlotte County is currently located within the 941 area code, and any change in the area code will directly impact County residents, businesses, schools, hospitals, and government offices.

2. The Board of County Commissioners of Charlotte County on July 11, 2000, authorized the undersigned to intervene in this proceeding, as at least two of the proposed relief plans would split Charlotte County into two area codes, and a third would separate a community partially located in Charlotte County.
