ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated October 20, 2000, PurePacket Communications of the South, Inc., holder of Alternative Local Exchange Telecommunications (ALEC) Certificate of Public Convenience and Necessity No. 7430, and holder of Interexchange Telecommunications Certificate (IXC) Certificate of Public Convenience and Necessity No. 7446, requested that Certificates Nos. 7430 and 7446 be amended to reflect the new corporate name, Broad River Communication Corporation. Upon review of the Department of State, Division of Corporations' records, it appears that PurePacket Communications of the South, Inc. has properly registered the new corporate name. Accordingly, we find it reasonable to amend Certificates Nos. 7430 and 7446 to reflect the new corporate name.

This Order will serve as the amended ALEC Certificate of Public Convenience and Necessity No. 7430 and as the amended IXC Certificate of Public Convenience and Necessity No. 7446 for Broad River Communication Corporation. Broad River Communication Corporation should retain this Order as evidence of the name change.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by PurePacket Communications of the South, Inc. to change the name on Certificates Nos. 7430 and 7446 from PurePacket Communications of the South, Inc. to Broad River Communication Corporation is hereby approved. It is further

ORDERED that this Order will serve as Broad River Communication Corporation's amended certificate and that this Order should be retained as evidence of the name change. It is further

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of

Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
