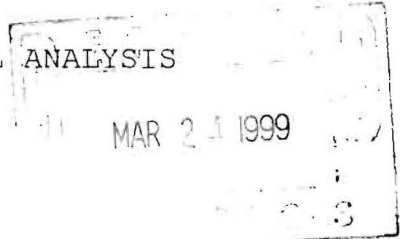

On June 8, 1999, when copies of certain portions of staff's audit working papers regarding FPU's Purchased Gas Adjustment were delivered to the utility at the audit exit conference, the utility requested that these documents be temporarily excepted from public access in accordance with the provisions of Rule 25-22.006(3)(a)(2), Florida Administrative Code (FAC). On June 16, 1999, staff filed document 07296-99 consisting of those specified portions of staff's audit working papers. These documents are currently held by the Division of Records and Reporting and designated as temporarily exempt from public access.

On June 28, 1999, the utility filed a request pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006(3)(a)(2) and (4), FAC, that selected portions of the working papers prepared by staff during the audit receive confidential classification. The utility's request included highlighted copies (Document 07805-99) and redacted copies (Document 07806-99) for public use.

Pursuant to Section 119.07, F. S., documents submitted to this Commission are public records. The only exemptions to this law are specific statutory exemptions and exemptions granted by governmental agencies pursuant to the specific terms of a statutory provision. Section 366.093(3)(d), F.S., provides the following exception:

"Proprietary confidential business information means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person's or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public. Proprietary confidential business information includes, but is not limited to:....

- (d) Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms...."

According to Section 366.093, F. S., and Rule 25-22.006, FAC, the utility has the burden of demonstrating that materials qualify for confidential classification. According to Rule 25-22.006, FAC, the utility must meet this burden by demonstrating that the information is proprietary confidential business information, the disclosure of which will cause the utility, the provider of the information or the ratepayer harm.

### **Staff Analysis of FPU's Request**

Analysis of the utility's request and listing of confidential materials reveals the sensitive information presented in the filing consists of invoices and summaries describing gas purchases during the period being audited. Specifically, the utility identified that the following type of information was reported within the working papers:

- 1) Negotiated gas supplies purchased from suppliers other than Florida Gas Transmission Company;
- 2) Deliveries by Gate Station;
- 3) Deliveries competitively made "off system";

FPU reports price of gas purchased varies based upon the operational flexibility of each contract. Release of supplier names and gas tendered by gate station would be detrimental to the interests of FPU and its customers since it would supply a competitor with a list of FPU's suppliers and operating information.

- 4) Names of Gas Suppliers;
- 5) Information concerning totals paid to gas suppliers; and

According to FPU, releasing information regarding the names of gas suppliers or monies paid to these suppliers could provide competing gas suppliers with an advantage in contracting. Suppliers may be less likely to make price concessions. Release of such information has the potential to lead to inflated price fixing by gas suppliers. Potentially, release of the aforementioned information may result in higher gas costs which would have to be passed along to FPU's customers.

6) Information concerning gas imbalances traded

FPU reports these trades are pursued with other pipeline customers. For competitive purposes only, FPU must be assured that no other pipeline customer will be able to ascertain the parties involved in this transaction with FPU nor the prices of the components of such transactions nor the quantities involved in these transactions. Otherwise future transactions of this type may be put at undue risk.

FPU asserts information identified in its request is contractual information which, if made public, "would impair the efforts of FPU to contract for goods or services on favorable terms" as defined by Section 366.093(3)(d), Florida Statutes. FPU goes on to state the information at issue is intended to be and is treated by FPU as proprietary and confidential.

**Confidential Classification Period**

Section 366.093(4), Florida Statutes, limits the length of confidential protection to 18 months unless, for good cause shown, a longer protection period is appropriate. FPU has requested that the material be held as confidential for at least 18 months.

**Staff Recommendation**

Based upon a reading of the utility's request and the information at the subject of the request, we recommend the material be granted a confidential classification for 18 months.
