As you requested, staff has calculated the interest on the overcharges due to the CenturyTel Telecommunications, Inc. customers. The total refund amount of \$9,111.72 consists of \$8,130.65 in overcharges and \$981.07 in interest. This calculation assumes that the overcharges were incurred evenly from February 1999 to August 1999 and that they will be refunded evenly in March 2001. The appropriate interest rate is the average 30-day commercial paper rate for each month. The last available monthly interest rate of 6.58% is used for the future months past December 2000. Attached is a schedule which shows the calculations.
