
The enclosed pages are submitted as proof that we have complied with the Florida Public Service Commissions' Order for refunds to be issued.

The amount we have refunded is less than what the Commission requested. This is explained by the following:

1. When we purchased LRPI we continued to charge the rates indicated in Order #: PSC-01-0424-PAA-WU - Page 3 - Table 1 - Column 4 - for a period of two (2) months.
2. It was assumed by both parties that the overcharge began at day one.
3. This results in a credit of \$1,696.80 for the base rate only. The remaining difference is in the gallons over the minimum.
