RE: Request for Permission from Comptroller's Office to Write-Off the RAFs for the years 2000 and 2001 for OnSite Access Local LLC (TX424 and TJ360).

On July 31, 2001, Docket No. 011002-TP was established to address TX424 and TJ360's failure to remit RAFs for the year 2000. By Order No. PSC-01-2168-PAA-TP, issued on November 5, 2001, the Commission approved the cancellation of TX424 and TJ360's Interexchange Telecommunications Certificate No. 7425. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs for the years 2000 and 2001 for TX424 and TJ360.
