Dear Chairman Jaber:

This letter, pursuant to Rule 25-30.430, Florida Administrative Code, requests approval of a test year for Cypress Lakes Utilities, Inc. ("Company"). The Company intends to submit an application for general rate relief to the Florida Public Service Commission for its water and wastewater systems located in Polk County, Florida. The Company intends to submit the minimum filing requirements ("MFRs") on or before September 30, 2002. The Company intends to utilize the PAA process and will be requesting interim rates.

Water and wastewater rates have not been set since the Company acquired these systems. The transfer was approved in Order No. PSC-98-0993-FOF-WS and rate base subsequently established as of December 31, 1997 in Order No. PSC-00-0264-FOF-WS. The current rates, subject to indexing and pass through increases, were set by Polk County on August 6, 1996 and grandfathered by this Commission in Order No. PSC-97-0569-FOF-WS.

The Company proposes a test year of the year ending December 31, 2001. The Company believes that year is representative of current operations and is a representative period to measure the cost of service and to establish new rates. Since the expenses incurred are typical and it is the most current year for which financial information is available. There has been no material growth in the systems. There
