TX430).


On August 12, 2002, Docket No. 020895-TP was established to address ConnectSouth Communications of Florida, Inc.'s (ConnectSouth) request for cancellation of its Alternative Local Exchange Telecommunications (ALEC) certificate and Interexchange Telecommunications (IXC) certificate due to Chapter 11 bankruptcy. By Order No. PSC-02-1539-PAA-TP, issued on November 12, 2002, the Commission approved the cancellation of ConnectSouth's ALEC Certificate No. 7473 and IXC Certificate No. 7474. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs, including penalties and interest, for the years 2000, 2001, and 2002 for ConnectSouth.
