

RESPONSE TO ORDER NO. PSC-11-0160-PCO-WS

Grove Land Utilities, LLC and Bluefield Utilities, LLC (hereafter "Grove Land/Bluefield"), by and through their undersigned attorneys, hereby file this Response to Order No. PSC-11-0160-PCO-WS, and in support thereof would state as follows:

1. This matter is currently in abatement by PSC Order No. PSC-11-0160-PCO-WS until April 30, 2011.

2. These consolidated applications were originally the subject of six objections (Okeechobee Utility Authority, St. Lucie County, Martin County, Fort Pierce Utilities Authority, Indian River County, and the City of Port St. Lucie). To date, ongoing negotiations between the applicants and the objecting local governmental entities have resulted in a settlement with Okeechobee Utility Authority, Fort Pierce Utility Authority, Indian River County and the City of Port St. Lucie. Discussions and negotiations remain active and ongoing with the two remaining objectors (St. Lucie County and Martin County).

3. Grove Land/Bluefield do not, at this time, intend to request a further abatement of this proceeding. Within 14 days of the date of this filing, Grove Land/Bluefield will initiate consultations with the Commission staff, and Counsel for the other parties to this proceeding, to



discuss the best way to proceed, the rescheduling of this matter, and other issues pertinent to the same. Order No. PSC-11-0160-PCO-WS directed that Grove Land/Bluefield apprise the Commission of the status of the negotiations. As indicated in Paragraph 2 above, negotiations are continuing.

WHEREFORE, and in consideration of the above, Grove Land/Bluefield respectfully requests that the Commission acknowledge the above and direct Grove Land/Bluefield to consult with the Commission staff and the other parties, as referenced hereinabove, and to apprise the Commission of the position of the various parties on the rescheduling of this matter, no later than May 13, 2011.


