The primary difference is that the amount per the correspondence was just the salary amounts and did not include taxes and benefits. Also the correspondence amount did not include those employees who allocate their time among the various utilities, which allocations change monthly. (Those allocated employees code their time to the particular utility for work done). The Annual Report amounts accurately reflect test year actual salaries, taxes and benefits, and the allocated time from the employees mentioned.

Staff has noticed a difference concerning the amount recorded in Accounts 601 and 701 - Salaries and Wages – Employees between the 2021 Annual Reports and a breakdown of salary expenses provided to staff by the Utility earlier this year.

Please review the below information and advise staff of the reason for the difference in the salary amounts.
