Homeowners Insurance: Used to be \$4000/year now it's \$14,000/year!

Electric: Used to be \$150/mo -- now it's \$375/mo

People are sweating in our homes, unable to pay health insurance premiums.

THIS MUST END!

FPL's proposed \$9.0 **BILLION** rate hike does NOT bring DOWN our costs.

Only a **SNOB** who has lost touch with real people would Brazenly seek another rate increase for more idiotic SOLAR farms and battery banks which do NOTHING but add to our electric BILL and destroy the environment.

NO MORE SOLAR!

We are DONE WITH SOLAR. It does NOT work!

Please send FPL packing. TELL them to get back to work on the proven technology for electricity that is reliable and less costly, like we've had BEFORE.

PLEASE REJECT PSC Docket 2025-0011.

IMPORTANT, NOTE THIS:

1. New electric capacity 2019-2025 by Florida regulated utilities is solar and battery storage *only*. FPL should **try non-diversified investment with their own retirement portfolios, not ours!**
2. 10-yr site plans in SERC Florida project 91% of 2025-2034 of new capacity is solar and battery storage (BESS). **INSANITY!**
3. The equipment (thin film PV and lithium battery parts) comes from CHINA. and Chinese sub-vendor countries. **FOOLISH!!**
4. Only ~5.2 hrs. ave/Hrs per day will be added per the NREL, DOE Berkeley National Labs and Net accredited capacity factor of Florida Solar power is only 23%. **YES, that says 23%!**
5. The cost of **SOLAR is 8.5X** that of the advanced gas-fired **combined cycle power technology** installed across Florida 2010-2019. **SOLAR costs 4.25X** the new combined cycle build cost estimates. **HELL _O!**

6. **BATTERY** storage required to back up just 2-3 hrs of SOLAR (intermittent), costs **3.9X** the advanced combined cycle power. **NO NO NO!**
7. SOLAR is **NOT reliable**. **Winter, dark, etc. DUH!**
8. Power providers are ALREADY suggesting that customers should SWITCH to use electricity from **midnight-5AM! I can't wait to alter my work hours!**
9. The Docket assumes existing constant duty, base load power plants will be shuttered -
!?. **Let's just SHOOT OUR FOOT, shall we - FOOLS!**
10. FPLs 74.5MW solar farms consume on average, **680 acres EACH! UGH!!** FPL plans to waste **192,000 Beautiful acres on STUPID Solar Farms!** The same OUTPUT (KwH electrical capacity/year delivered) by combined cycle would only take roughly **66 acres**.
11. ☹ **HEAR THIS:** As large quantities of utility scale solar farms are added in a given region, their **incremental capacity factor declines markedly, by up to some 40%**, according to MISO and WECC studies.
12. Solar Farms (W. Europe, Australia) cause DRAMATIC RATE INCREASES. They also cause interim supply shortages!

FPL's plan **SUCKS in every way imaginable!**

13. Proven technology is BETTER. Awards from Duke Energy to GE Vernova (11 units) along with Nextera, target hyperscaler and data center clients.

FPL is a LAUGHING STOCK for making this absurd proposal! FPL's proposed \$9.0 BILLION rate hike is an AFFRONT!

PLEASE demonstrate intelligence and REJECT this **LOSER** of a Plan. PLEASE make them STOP WASTING our money and our beautiful LAND on Stupid Solar Lunacy!

The People are MAXED OUT. We cannot afford "more for less."
