The purposes of this prehearing conference on settlement are to: (1) simplify the issues and major elements; (2) identify the positions of the parties on the issues and major elements; (3) consider the possibility of obtaining admissions regarding facts and documents which will avoid unnecessary proof; (4) discuss exhibits and prehearing submissions; (5) discuss the order of witnesses; and (6) consider such other matters as may aid in the disposition of the action, including but not limited to the Joint Motion to Approve Stipulation and Settlement Agreement (filed August 26, 2025) and the Response in Opposition (filed August 29, 2025).
