Greetings Governor Desantis and Staff,
Hope this note finds you all well.

It appears FP&L has increased their rates. Very difficult to keep up with and as we do, we suffer in other aspects.

I help cover the expenses at my elderly parent's home (91 yrs old and 89, Mom suffering from Alzheimer's requiring supervision and assistance 24/7) and in my home my wife suffers from a medical disability.

Gov., I retired recently and on a fixed SS income and am certain am not the only one in this position within our State. Is there anything you can do to help control, prevent further fee hikes? Similarly with Homeowners insurance, not to mention healthcare insurance.

It's very very difficult and chronic stressor worrying if will be able to afford it. Both my wife and I worked for decades as First Responders in law enforcement and Fire-Rescue and dealing with wear and tear on our physical and mental state of being.

I admit, I didn't know til just few years ago that FP&L was privately owned, not managed by the Govt such as Water&Sewer, or Roads&Bridges, the Public School system... nor did I know the Federal Reserves is privately owned too. My error in not having educated myself to those facts before.

Governor, please consider proposing for the amounts of money given to foreign countries in assistance be reduced as much as possible and those savings be used to assist the USA Citizens and legal residents by off-setting, or subsidizing those increased costs for FP&L, please. Too bad it couldn't be operated by the Govt as it manages other utilities- perhaps consideration should be provided for that too.
