> FPL ACTS AS A FOR PROFIT ORGANIZATION COLLECTING RENTAL FEES FROM OTHERS THAT USER DOLLARS WERE EXPENDED TO ESTABLISH THEIR DELIVERY SYSTEM NEEDS RECOGNITION IN RATE SETTING. ALLOWING FPL TO RENT THE SYSTEM TO AT&T AND OTHERS THAT USER DOLLARS PAID TO SET UP AND ACTING AS A BILLING AGENT FOR HOME

SERVICES AND OTHERS MUST BE TAKEN INTO ACCOUNT IN ESTABLISHING THE RATE.
