Issue 2: Should OPC's Motion for Reconsideration of Order No. PSC-2025-0196-FOF-WS be granted? Recommendation: Staff recommends that OPC's Motion should be granted in part and denied in part. Staff recommends that two of OPC's proposed adjustments to the revenue requirement should be granted. This will result in a downward calculation of revenue requirement by \$778 and \$880 for the Utility's water and wastewater systems respectively. Staff recommends that OPC has otherwise failed to show where the Commission overlooked or failed to consider a fact or law in rendering its decision. Therefore, in all other respects, OPC's Motion should be denied.
