On August 29, 2025, Peoples Gas System (Peoples or utility) filed a request for confidential classification for Document No. 08509-2025. This document contains various project maps related to the Downtown Tampa Project, provided in Peoples' response to Commission staff's Sixteenth Set of Interrogatories, No. 189. Peoples has redacted this information in its entirety, citing competitive interests, the disclosure of which would impair the competitive business of the utility. Furthermore, Peoples states that the utility treats the confidential information contained as private and has not publicly disclosed the information.

Staff has reviewed the document and concurs with Peoples that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes (F.S.), whereby disclosure of the information would impair the competitive business operation of the utility. Furthermore, staff agrees this confidential document relates to Critical Energy Infrastructure Information, as defined by the Federal Energy Regulatory Commission and described in Peoples' request for confidential classification (DN 08508-2025). Critical Energy Infrastructure Information further meets the requirements set forth in Section 366.093(3)(c), F.S., information relating to security measures, systems, or procedures. Therefore, staff recommends the request by Peoples for confidential classification of Document No. 08509-2025 be approved.
