**Centrex RACF (Remote Access Call Forwarding) and CSA Revision**  
(FL2005-166)

**Introduction**

This tariff introduces a new optional feature, Remote Access Call Forwarding for Centrex (RACF) and makes Centrex available for Contract Service Arrangements (CSA).

**Proposed Tariff**

RACF is an optional feature that allows a Centrex station user to activate or deactivate and redirect call forwarding from a remote location. Currently customers only have that capability from their primary line.

CSA Revision allows Centrex services to be available to customers under a Contract Service Arrangement. Previously this service was not available in either a CSA or a Special Assembly.

**Revenue Impact**

BellSouth will cover its cost for this service.
