Competitive Acquisition \$50 Reward #1492

Overview

The Competitive Acquisition \$50 Reward promotion is scheduled to begin on 10/01/2007 and end on 12/31/2007. Competitive Acquisition customers who are with another local service provider or are wireless substituors will be eligible for a \$50 reward when selecting BellSouth local service, purchasing BellSouth(R)Complete Choice(R) family plan or BellSouth(R) PreferredPack plan and BSLD non-Unlimited calling plan. The customer must select Bundle 39 or 40.

Promotion Specifics

Competitive Acquisition customers who are with another local service provider or are wireless substituors who purchase Complete Choice or BellSouth Preferred Pack AND BSLD non-Unlimited will be eligible for a \$50 Reward. The customer must be in BUN 39 OR BUN 40.
