The certificate holder has complied with Section 364.335(3), Florida Statutes, by providing the Florida Public Service Commission notice in writing of its request for voluntary cancellation of its certificate.

Neither the cancellation of the certificate nor the failure to receive a RAF return notice shall relieve Hargray of Tallahassee LLC from its obligation to pay RAFs. This includes the obligation to pay any penalty and interest that may be due for the current year. Failure to pay the amounts owed to the Florida Public Service Commission will result in the Company's fees, penalties and interest being sent to a collection agency.

Pursuant to Section 2.07.C.5.f., Administrative Procedures Manual, the voluntary cancellation is acknowledged and the docket should be closed.

Hargray of Tallahassee LLC (the “Company”) respectfully submits this letter to the Florida Public Service Commission (the “Commission”) to cancel its existing telecommunications certification and any tariffs that may be on file with the Commission. The Company holds Certificate of Authority No. 8967, which authorizes the Company to provide telecommunications service throughout the state of Florida. The Company’s Certificate was granted in Docket No. 20210173-TX on December 10, 2021 and was deemed final on January 4, 2022.
