### AMENDATORY ORDER

#### BY THE COMMISSION:

On April 9, 1990, this Commission issued Order No. 22893 amending Certificate No. 444-W (Desoto County), held by General Development Utilities, Inc. (GDU), to include additional territory in Charlotte and Sarasota Counties. That Order also granted GDU Certificate No. 462-S in Desoto, Charlotte and Sarasota Counties and approved rates and charges for GDU's West Coast Division.

The table on Page 7 of Order No. 22783 incorrectly combined the residential and general service sewer rates for the Charlotte County portion of GDU's West Coast Division. Also, the table on Page 11 incorrectly combined the residential and general service water rates for the Sarasota County portion of GDU's West Coast Division. As a result some of the rates were omitted. The table on Page 7 of Order No. 22783 is, therefore, amended to reflect all of the residential and general service sewer rates for the Charlotte County portion of GDU's West Coast Division as follows:
