SUMMARY OF RULE

This rule is amended to delete Forms PSC/CMU 24, Annual Report; PSC/RTA2, RTA3 and RTA4 the Rail Transportation Annual Report forms; and PSC/RTA5, Regulatory Assessment Fee-Railroad from the list of Commission forms found in Rule 25-22.004.

SUMMARY OF HEARINGS ON THE RULE

No hearing was requested and no hearing was held.

FACTS AND CIRCUMSTANCES JUSTIFYING THE RULE

The revised rule deletes Form PSC/CMU 24 from the list of Commission forms in Rule 25-22.004 because revised Rule 25-4.018 incorporates Form PSC/CMU 24 by reference and provides the rule number, title, and effective date. Rule 25-4.018 also explains how the form may be obtained so it is unnecessary and may be confusing to also include it in the list of Commission forms found in Rule 25-22.004.

The Commission forms relating to rail transportation (PSC/RTA 2, 3, 4, and 5) are deleted because the Commission no longer regulates railroads.
