Notice is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for formal proceeding pursuant to Rule 25-22.029, Florida Administrative Code.

Real-Time Services, Inc., filed an application for an interexchange certificate on April 16, 1990. The application contained the required background information and its proposed tariff.
