ORDER GRANTING ORANGE-OSCEOLA UTILITIES, INC.'S
MOTION FOR EXTENSION OF TIME
AND
REVISING ORDER ON PROCEDURE

On January 8, 1996, this Commission issued an Order Establishing Procedure (Order No. PSC-96-0018-PCO-WS) which established requirements for discovery, filings, notice, testimony and exhibits, prehearing statements, prehearing conference, waiver of issues, document identification, controlling dates, and the use of confidential information. According to that Order, Orange-Osceola Utilities, Inc.'s (OOU or utility) testimony is due February 6, 1996.

On January 16, 1996, OOU moved for a seven-day extension of time in which to file its direct testimony and exhibits. In support of its motion, OOU states that it did not receive the Order Establishing Procedure until January 15, 1996, when the utility's attorney assigned to this docket was out of town attending a continuing legal education seminar. Therefore, OOU lacked sufficient time in which to file its testimony and exhibits. OOU provided copies of its motion to all parties. Parties did not file an objection to OOU's motion.

In consideration of the above, OOU's motion is granted. In order to allow time for OOU to file its testimony, and to provide all other parties and Staff the same amount of additional time in which to file testimony due subsequent to OOU's deadline, the following dates shall control in this docket:
