ORDER MODIFYING PROCEDURAL SCHEDULE

By Order No. PSC-96-0720-PCO-TL, issued May 28, 1996, the procedural schedule in this docket was established. At the July 16, 1996 agenda conference, the Commission voted, in Docket No. 941281-TL, to require the parties to address concerns regarding the effect of the Telecommunications Act of 1996 on BellSouth Telecommunications, Inc.'s ability to initiate interLATA (local access and transport area) calls. These same concerns are present in this docket. Therefore, it is appropriate to modify the procedural schedule to allow time to review the impact of the Telecommunications Act of 1996 on the issues in this docket.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
