BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Fablia Service Commission that the action discussed herein as prelaminary in nature and will become final unless a person whose interests are substantially affected files a petition for a termal proceeding, pursuant to Rule 25-22.029, Florida Administrative Tode.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated December 18, 1997, Factition International, L.L.C. (FaciliCom) filed with this Commission a petrion for approval of pro-forma corporate reorganization whereby a recently

created holding company, Facilition International, Inc., will be inserted directly above Facilition in the purporate chain as 100 parent. Facilition is the holder of Interexchange Telecommunications Certificate (IXT No. 4504. The company has stated that the transaction will be completely seemless to the customers in terms of the services they have and will receive.

We determine that Faciliton has most the requirements of Section 364.33, Florida Statutes. Accordingly, we find that the pro-forma corporate reorganization is in the public interest, and we approve it pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that FaciliCom International, L.L.C.'s pro forma corporate reorganization is hereby approved. It is further

## NOTICE OF FURTHER PROCEEDINGS OF JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 1.0.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

The action proposed herein is preliminary in nature and will not become effective or final, except as provided by Rule 25-22.029, Florida Administrative Code. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, as provided by Rule 25-22.029(4), Florida Administrative Code, in the form provided by Rule 25-22.036(7)(a) and (f), Florida Administrative Code. This petition must be received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on April 2, 1998.

In the absence of such a petition, this order shall become effective on the day subsequent to the ab ve date as provided by Rule 25-22.029(6), Florida Administrative Tede.

Any objection or protest filed in this locket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party substantially affected may request judicial review by the Florida Supreme Court on the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filling a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court.
