AMENDATORY ORDER

BY THE COMMISSION:

On November 30, 1998, we issued Order PSC-98-1591-FOF-TX. The Order granted a certificate to provide Alternative Local Exchange Telecommunications (ALEC) services to YourTel, Inc. Due to a scrivener's error, the certificate number was incorrectly listed as 5761. The correct certificate number is 5762. Therefore, Order No. PSC-98-1591-FOF-TX is amended to correctly state that YourTel, Inc. is the holder of ALEC Certificate No. 5762.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-98-1591-FOF-TX is hereby amended to reflect that YourTel, Inc. is the holder of ALEC Certificate No. 5762. It is further
