ORDER GRANTING MOTION FOR EXTENSION OF TIME,
RESCHEDULING CONTROLLING DATES, AND
CANCELLING PREHEARING CONFERENCE AND HEARING

On July 6, 1999, the Office of Public Counsel (OPC), and Representative Mike Fasano, Intervenor, filed their joint Intervenor's Motion for More Time to Provide Prefiled Testimony (Motion). In that Motion, the intervenors request that they be allowed to file their testimony after August 13, 1999. The utility has orally responded that it has no objection to this motion being granted as long as it is provided a similar extension for the filing of rebuttal testimony.

Upon consideration, the Motion shall be granted, and the Intervenor shall have up to and including August 16, 1999, to prefile their testimony. Further, the controlling dates for the filing of any staff testimony and exhibits, rebuttal testimony and exhibits, and prehearing statements set forth in the Order Establishing Procedure, Order No. PSC-99-0514-PCO-WS, are revised as follows:



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
