NOTICE OF PROPOSED AGENCY ACTION
ORDER DENYING CERTIFICATE TO PROVIDE INTEREXCHANGE
TELECOMMUNICATION SERVICE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Quest Telecommunications, Inc. filed an application for a Certificate of Public Convenience and Necessity to provide statewide Interexchange Telecommunications (IXC) service. The application lacked the required tariff information to have a complete application on file with this Commission. Therefore, it is not in the public interest to grant an IXC certificate to Quest Telecommunications, Inc.

Based on the foregoing,

ORDERED by the Florida Public Service Commission that we hereby deny Quest Telecommunications, Inc.'s application to provide Interexchange Telecommunications service. It is further


