AMENDATORY ORDER

BY THE COMMISSION:

On August 16, 2010, we issued Order No. PSC-10-0519-FOF-WS approving application for transfer of Certificate Nos. 577-W and 498-S from Keith & Clara Starkey d/b/a Heather Hills Estates to Heather Hills Estates Utilities, LLC, effective August 3, 2010. However, due to a scrivener's error in Schedule 1, the 4-inch wastewater residential and general service charge incorrectly showed \$713.76. Therefore, Order No. PSC-10-0519-FOF-WS is amended to reflect that the correct amount for 4-inch wastewater residential and general service charge is \$731.76.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-10-0519-FOF-WS is hereby amended to reflect as described herein. It is further

ORDERED that Order No. PSC-10-0519-FOF-WS is reaffirmed in all other respects.
