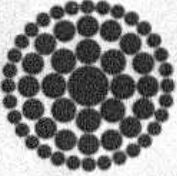

FLORIDA POWER CORPORATION PETITION
FOR APPROVAL OF STANDARD OFFERS FOR
PURCHASE FROM QUALIFYING COGENERATION
AND SMALL POWER PRODUCTION FACILITIES

Pursuant to Commission Order No. 23625 and Commission Rule 25-17.0832(3)(a), F.A.C., Florida Power Corporation (Florida Power) hereby submits its two Standard Offers For Purchase From Qualifying Cogeneration And Small Power Production Facilities (Qualifying Facilities): (1) Standard Offer For Purchase Of As-Available Energy From Qualifying Facility, and (2) Standard Offer For Purchase Of Firm Capacity And Energy From Qualifying Facility Less Than 75 MW Or A Solid Waste Facility. In support of this Petition, Florida Power submits the following:

1. Commission Order No. 23625 called for utilities, including Florida Power, to file their generation plans and accompanying standard offer contracts, rates and interconnection agreements for qualifying facilities (QFs) on or before October 30, 1990. By letter dated October 24, 1990, Florida Power notified the Commission that only its Generation Plan, but not the other documents, would be filed on the 30th. Accordingly, Florida Power filed its Generation Plan on the 30th and now seeks a two-week

extension of time, until today, in which to file its accompanying contracts, rates and interconnection provisions. In support of this request for extension of time, Florida Power refers to the reasons set forth in its October 24th letter, which is attached to this Petition.

2. The Standard Offer For Purchase Of As-Available Energy From Qualifying Facility, and the Standard Offer For Purchase Of Firm Capacity And Energy From Qualifying Facility Less Than 75 MW Or A Solid Waste Facility submitted with this Petition supersede Section No. IX of Florida Power's current tariff sheets (Rate Schedules COG-1 and COG-2).

3. In the interests of efficiency, ease of administration, and in order to avoid multiple documents, Florida Power has incorporated its standard offer contracts, rates and interconnection requirements into one package for as-available purchases and another package for firm capacity and energy purchases. The Standard Offer For Purchase Of As-Available Energy From Qualifying Facility is comprised of a Standard Offer Contract and three appendices which contain (1) interconnection scheduling and cost responsibility provisions, (2) operating procedures, and (3) rates. The Standard Offer For Purchase Of Firm Capacity And Energy From Qualifying Facility Less Than 75 MW Or A Solid Waste Facility is comprised of a Standard Offer Contract and four appendices: (1) interconnection scheduling and cost responsibility provisions, (2) operating procedures, and (3) rates, (4)

transmission service standards for QFs that wheel to Florida Power, and (5) Commission Rules 25-17.080 through 25-17.091, F.A.C.

4. Florida Power has revised its Standard Offer For Purchase Of Firm Capacity And Energy to reflect rates based on a 1991 combustion turbine unit, a 1991 pulverized coal unit, and a 1997 combustion turbine unit.

5. The Standard Offer For Purchase Of Firm Capacity And Energy is available for QF facilities south of Florida Power's Central Florida Substation. It is also available for QF facilities north of that substation, provided that Florida Power can make interface import capability available and the QF reimburses Florida Power for such costs. The Standard Offer For Purchase Of As-Available Energy is available without regard to facility location, given that Florida Power can refuse to purchase as-available energy if there exists insufficient interface import capability to do so.

6. The Standard Offers submitted with this Petition comply with the Commission rules respecting utility obligations with regard to cogenerators and small power producers, Rules 25-17.080 through 25-17.091, F.A.C.

WHEREFORE, for all of the reasons stated above, Florida Power respectfully requests approval of its Standard Offer For Purchase Of As-Available Energy From Qualifying Facility, and Standard Offer

For Purchase Of Firm Capacity And Energy From Qualifying Facility
Less Than 75 MW Or A Solid Waste Facility.
