STATEMENT OF COMMISSION ACTS TO BE REVIEWED

Appellant, Gulf Power Company, by and through its undersigned counsel and pursuant to Rule 9.200(a)(2), Florida Rules of Appellate Procedure, makes the following statement of the act of the Florida Public Service Commission to be reviewed, saying:

The decision of the Florida Public Service Commission to impose a "mismanagement penalty" on Gulf Power Company by reducing the Company's authorized return on equity by 50 basis points, from 12.55 percent to 12.05 percent, for two years and consequently reducing the allowed rate increase by \$2,293,000 on an annual basis for that two year period.
