ORDER GRANTING PETITION TO INTERVENE AND PROVIDING AN EXTENSION FOR INTERVENOR TO FILE TESTIMONY

BY THE COMMISSION:

By Petition filed April 1, 1991, Robert B. Pierce requests leave to intervene in this proceeding. Mr. Pierce is the Vice President of Viva Villas Civic Association, Inc. and a customer of Viva Villas Sewer System. In support of his Petition, Mr. Pierce states that the proposed transfer is not in the public interest; it would be financially favorable to be served by Pasco County; and Pasco County would be a more reliable and efficient provider of service. No response in opposition to the Petition has been filed.

Mr. Pierce has requested that he be granted Class B practioner status. Self-representation is not precluded by Rule 25-22.008, "Practioners", Florida Administrative Code. Therefore, we find it unnecessary to grant the request of Mr. Pierce for Class B practioner status in order for him to participate in this proceeding.

Having reviewed the Petition, it appears that Mr. Pierce's substantial interests may be affected by this proceeding. Therefore, the Petition should be granted. Pursuant to Rule 25-22.039, Florida Administrative Code, Mr. Pierce takes the case as he finds it. However, in the interest of fairness, extending the due date for filing Intervenor's Testimony and Rebuttal Testimony would be appropriate in this case. Therefore, Intervenor's Testimony is due Friday, April 5, 1991, and Rebuttal Testimony is due Wednesday, April 10, 1991.

It is, therefore,

ORDERED by the Florida Public Service Commission that the Petition to Intervene, filed by Robert B. Pierce, is hereby granted. It is further


