has filed an National Operator Services, Inc. (NOA) application for an interexchange certificate. The application contained the required background information as well as the proposed tariffs, and indicated that NOA would also be providing After considering the alternative operator services (AOS). application, it appears that NOA is technically capable of providing service. Therefore, we find that it is in the public interest to grant a certificate to NOA, and it is our intention to grant the certificate. Interexchange carriers (IXCs) are subject to the provisions of Rules 25-24.455 through 25-24.495, Florida Administrative Code. Additionally, by Order No. 16804, IXCs are prohibited from constructing facilities to bypass a local exchange company without express prior approval from the Commission. Further, AOS providers are bound by our decisions in Docket No. 871394-TP, including, but not limited to Order No. 20489, issued December 21, 1988.
