ORDER GRANTING EXTENSION OF PERIOD FOR RECONSIDERATION OF ORDER NO. 24877

BY THE COMMISSION:

Intermedia Communications of Florida, Inc. (ICI) filed on August 14, 1991, a Motion for Extension of Time to File Motion for Reconsideration of Order No. 24877. Order No. 24877, issued in this Docket on August 2, 1991, is the final order culminating an extensive investigation into the operations of alternate access vendors. ICI's pleading states that its counsel will be out of state through August 22nd. The period for reconsideration pursuant to Rule 25-22.060, Florida Administrative Code, ends August 19, 1991. ICI states that its motion is made in good faith because it needs additional time to file its motion for reconsideration.

Because of the significant nature of this Order, representing the authorization of a new category of participants in the telecommunications industry, we find it appropriate to waive Rule 25-22.060, Florida Administrative Code, and permit all parties a 21-day extension of the reconsideration period, which shall end Monday, September 9, 1991.

Based on the foregoing, it is, therefore,

ORDERED by the Florida Public Service Commission that Intermedia Communications, Inc.'s request for an extension of the reconsideration period is hereby granted. All parties shall have until the close of business September 9, 1991, to file for reconsideration of Order No. 24877.

## NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section Florida Statutes, to notify parties of administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
