## NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING PAY TELEPHONE CERTIFICATES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for formal proceeding pursuant to Rule 25-22.029, Florida Administrative Code.

The individual companies listed in the caption of this Order filed applications for a certificate to provide pay telephone service (PATS). These applications were filed pursuant to Section 364.3375, Florida Statutes (1990), which provides that no person can provide pay telephone service without first obtaining from this Commission a certificate of public convenience and necessity to provide such service. Sections 364.335 provides for the application for a certificate of public convenience and necessity and sets forth guidelines for the application process. The

In reviewing the applications of these companies, we find that they contain the information required for certification as set forth in Sections 364.3375 and 364.335, as well as the Rules cited above. Based on the foregoing, we propose to grant each of the companies listed in the caption of this Order a certificate to provide pay telephone service consistent with the conditions and requirements set forth in Rules 25-24.505 through 25-24.520, Florida Administrative Code.

The dockets listed in this Order will be closed following expiration of the period specified in this Order unless an appropriate petition for hearing, protesting a specific application, is filed by one whose substantial interests may or will be affected by this proposed agency action, as provided by Rules 25-22.029 and 25-22.036(7)(a), Florida Administrative Code. A petition protesting a specific application filed by one whose substantial interests are affected will not prevent our proposed action from becoming final as to any other application listed in this Order.
