## ORDER ESTABLISHING HEARING PROCEDURES

## I. Background

This Docket was established pursuant to a September 14, 1990, consumer complaint to the Public Service Commission's Division of Consumer Affairs. The consumer wanted to have the Country Club of Miami moved from the Miami Exchange to the North Dade exchange. The change was desired because the Miami exchange does not have local calling to the Hollywood exchange while the North Dade exchange does have local calling to the Hollywood exchange. A survey of affected customers was conducted by Southern Bell Telephone and Telegraph Company (Southern Bell or the Company) between May 17, 1991 and June 16, 1991.

On August 20, 1991, by Order 910028-TL, the Commission issued a proposed agency action to move the Country Club of Miami from the Miami exchange to the North Dade exchange. That Order provided an opportunity for any customer in the affected area to voice opposition to the proposed boundary change. Several protests were received within the 45-day time period established for protesting the change. As a result of the protests, the Commission has scheduled a public hearing to allow all affected parties an opportunity to present testimony regarding whether the boundary between the Miami and North Dade exchanges should be altered to place the Country Club Area in the North Dade exchange.

# II. Public Hearing

The Commission will hold a public hearing regarding whether the boundary between the Miami and North Dade exchanges should be altered to place the Country Club Area in the North Dade exchange. The hearing will be held at the following time and place:

> 6:30 P.M. on November 21, 1991 American High School Auditorium 18350 NW 67th Ave. Hialeah, FL.

The hearing will begin promptly at 6:30 p.m. Staff will present its testimony at that time. If no interested parties are

present to speak by 7:00 p.m. the hearing will be adjourned.

III. Testimony

All affected persons who wish to testify will be allowed to speak at the hearing. The testimony at the hearing will be limited to arguments both for and against the boundary change.

Mr. Rick Cimerman of the Public Service Commission staff will present prefiled testimony regarding geographic, community of interest, balloting, and related considerations, and respond to questions regarding his testimony. Southern Bell will not file testimony in this proceeding but will be available to answer questions.

Anyone wishing to use a document for cross-examination or to enter a document into evidence during the hearing shall provide 15 copies of such document for use by the Commission and other parties.

## IV. Posthearing Procedures

All testimony from this proceeding will be transcribed and copies will be available from the Commission's Court Reporter by December 12, 1991. All parties may file post hearing statements of position which state that party's final position on the issues. Any such posthearing statement must be <u>received</u> by the Commission by January 3, 1992. Posthearing statements shall be addressed as follows:
