AMENDATORY ORDER

BY THE COMMISSION:

On October 30, 1991, this Commission issued Order No. 25273 acknowledging the amendment of South Broward Utility, Inc.'s (South Broward) certificated territory to include additional territory in Broward County. Attachment A of that Order contained several errors and omissions. The purpose of this Order is to correct Attachment A to correctly reflect the territory to be served by South Broward. At the bottom of the first page of Attachment A (Page 5 of the Order), the territory description incorrectly indicates that the Section No. is 29 rather than 3. That portion of the territory description should read:

The following described lands located in a portion of Section 3, Township 51 South, Range 40 East, Broward County, Florida:

Section 3

The North 1/2, and North 330 feet of the South 1/2.

Also, on the second page of Attachment A (Page 6 of the Order), part of the territory description was inadvertently omitted from Section 29. That portion of the territory description should read:

Section 29

All of the East 1/2 of the Southeast 1/4 lying South of the South New River Canal R/W, less the South 330 feet.

It is, therefore,

ORDERED by the Florida Public Service Commission that Attachment A of Order No. 25273 is hereby amended as set forth in
