In contrast, applying the calculation contained in the Commission's Order, Sugarmill Manor will be subsidizing customers such as the Florida Central Commerce Park and the South Forty Utility, Industrial Parks, which will receive subsidies of \$1,808.00 and \$3,471.000 per year, respectively.

- 4. Sugarmill Manor, Inc. received no notice by bill inserts or separate mailing that Southern States Utility was seeking or that the Public Service Commission was considering statewide uniform rates.
- 5. As demonstrated above and by the attached exhibits, the adoption of statewide uniform rates is unfair, unjust and discriminatory.
- 6. In all other respects, Sugarmill Manor, Inc. adopts the Motion for Reconsideration filed on behalf of Cypress and Oak Villages Association of Homosassa.

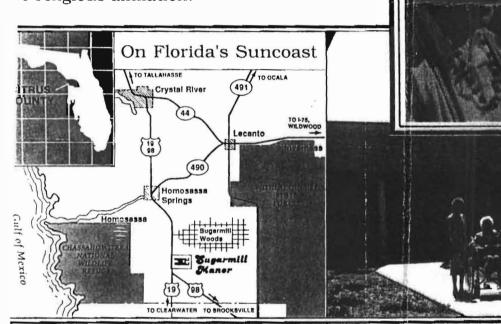
